U.S. Wheat Associates Sub-Saharan Wheat Storage Seminar Teaches Grain Storage and Fumigation Techniques in Tropical Locations

Storing grain in warm, tropical conditions is a challenge throughout the world in locations where high humidity levels and temperatures combine to create problems with mold and insect infestation.

To address these concerns, the IGP Institute partnered with U.S. Wheat Associates to deliver an online seminar to 129 registered participants from South Africa, Nigeria, Mozambique, Burundi, Kenya, Uganda, Malawi, Tanzania, Senegal, and Rwanda on December 14.

Carlos Campabadal, IGP feed manufacturing and grain quality management curriculum manager facilitated the course and provided information on wheat storage in tropical locations including proper storage techniques to use in warehouses, trucks, and bagged products. Additional topics included how to properly aerate grain in tropical weather along with information on the U.S. grain grading system and receiving grain at port facilities. The course concluded with a look at sanitation and pest control practices that featured a session on how to safely fumigate grain storage facilities.

Portions of the course were recorded in advance and given to the participants so they could view them before the three live Zoom lectures and the following question and answer sessions.
