IGP Institute Hosts USSEC Stepping Ahead with U.S. Soy Course at the K-State Olathe Campus

The IGP Institute and USSEC partnered to bring 37 participants to K-State's Olathe campus for a three-day course held April 26–28.

Animal nutritionists and feed industry professionals from Guatemala, Colombia, El Salvador, Panama, Peru, El Salvador, Honduras, Mexico, Costa Rica, Ecuador, Venezuela, and the Dominican Republic viewed presentations from guest faculty specializing in poultry and swine nutrition from multiple universities in the United States.

Lectures and presentations during the three-day course covered a variety of topics from specific animal nutrition requirements to feed additives and discussions of new technology, enzymes, protein requirements, and sustainability throughout the industry. The final sessions covered feed processing and grain management.

Each day concluded with a question and answer session and evening dinners at local restaurants. The final night ended with a closing ceremony banquet and the presentation of course certificates.
